Howatt made a motion to approve the 2024 meeting dates and the date of the 2024 water tour; Jallo seconded the motion, and the motion unanimously passed.

## **DEPARTMENT OF WATER RESOURCES:**

Director Andrea Travnicek, Devils Lake Project Engineer Yaping Chi, and Regulatory Chief Aaron Carranza were all present and gave updates from the ND Department of Water Resources. Director Travnicek discussed the State of Water she presented to the conference yesterday and the Capital Improvement Plan that Barlett & West Engineering is working on for the West Devils Lake Outlet. Yaping gave a synopsis of the Outlet Operations for the year that they were able to remove about 88,000-acre-feet between the two structures, and they were shut down for the season on October 24<sup>th</sup>. Aaron mentioned the Floodplain Administration meeting that he and staff members will attend in Devils Lake next week. Frith stated that he had asked DWR staff and FEMA representatives to present information regarding the Floodplain Administration and the Nation Flood Insurance Program (NFIP). The meeting will take place in Devils Lake, Tuesday December 12<sup>th</sup> at 10 AM.

#### **NADAWN SITES AND ALL-SEASON ADDITION:**

Daryl Ritchison attended and discussed the NDAWN (North Dakota Agriculture Weather Network) system and gages within the Devils Lake Basin. Daryl mentioned that he would have funds to install two all-season gages in the Devils Lake Basin, and he is flexible as to where they are placed and would like to work with the Joint Board to see where we would like to have them placed. The only thing that Daryl mentioned would be the site location to ensure that there would be no limitations to snow wind. He mentioned that the Webster and Brocket sites would be good locations. Daryl said that he will be installing all-season gages with funding from the Red River Joint Board throughout the Red River Basin, and two of those will be close to the Devils Lake Basin in Pekin and Baker NDAWN sites.

## USGS - Dan Thomas:

Dan Thomas, Supervisory Hydrologist, and Field Office Chief with the US Geological Survey Dakota Water Science Center in Grand Forks was in attendance and presented the information gathered through the Real-time gages within the Devils Lake Basin, the rise of lakes in the basin and discussed some changes coming in 2024. Dan went through the 2023 inflows into Devils Lake that USGS monitored and stated there were no significant inflows. Chairman Sateren, Frith, and board members thanked Mr. Thomas for his presentation.

#### **OTHER NEW BUSINESS:**

## **ELECTION of 2024 OFFICERS:**

Chairman Sateren stated that his time as chairman has run its course, and it was time to elect officers for 2024 for new Officers to be seated at the January meeting. It was noted that Howatt is the current vice-chairman, and it is standard that the current vice-chairman be elected chairman. Ash made a motion to nominate Howatt as Chairman and that nominations cease, and a unanimous ballot be cast, seconded by Tweed. Howatt was elected as the 2024 Chairman. Frith pulled up a listing of previous officers so members could see who has served most recently. Sateren opened the floor for nominations for the 2024 Vice-Chairman. Jallo made a motion to nominate Mike Tweed as 2024 Vice-Chairman, that nominations cease, and a unanimous ballot is cast, second by Ash, and the motion passed. Sateren congratulated the new officers. Board members and those present gave Sateren a round of applause, and Frith thanked Sateren for his leadership throughout this past year.

Frith reminded everyone that the next Joint Board meeting will take place on Wednesday, January 10<sup>th,</sup> in the Ramsey County Courthouse at 9 A.M.
