'JOINT BOARD SEEKING NOMINATIONS'

Nominations for the 2025 'Devils Lake Basin Water Stewardship Award' are being accepted by the Devils Lake Basin Joint Water Resource Board until Monday, November 3rd, 2025.

The award was established in December 2002 to honor individuals, groups, organizations, and projects that have demonstrated a commitment to enhancing the quality of life in the Devils Lake Basin community. This recognition is specifically for those who have made efforts to improve land and water stewardship.

- Arne Berg for his contributions to the residents of the Devils Lake Basin as a Ramsey County Commissioner and later as a State Water Commissioner (2017)
- Nelson County Water Resource Board for their efforts on the Michigan Spillway/Flood **Reduction Project (2018)**
- Devils Lake Access Committee for their ongoing commitment to providing recreational opportunities for all to enjoy the natural bounties that Devils Lake has to offer, regardless of water levels or people's physical abilities (2019)

- Dick Johnson, who served the City of Devils Lake for 32 years, 20 years as a City Commissioner and 12 years as mayor, as well as representing the Devils Lake Basin as a Commissioner on the North Dakota State Water Commission. During his time in office, Dick was instrumental in navigating the City of Devils Lake through unique water challenges and worked tirelessly to help develop the best flood control measures possible, given the complex issues surrounding Devils Lake (2023).

Board Chairman Mike Tweed announced, "Nominations will be accepted from any individual, organization, or governmental body within the Devils Lake Basin, which includes Cavalier, Eddy, Nelson, Pierce, Ramsey, Towner, and Walsh Counties."

Tweed explained that nomination information will be provided to County Commissions, Extension Agents, Soil Conservation Districts, and Water Boards in the seven counties. Additionally, nomination details can be obtained from any Joint Board member by contacting the Joint Board office located in the Ramsey County Courthouse in Devils Lake or by visiting www.dlbasin.com.

"All nominations will be evaluated by an independent panel of Basin residents who are knowledgeable about the four areas of the Devils Lake Basin Water Management Plan: Agriculture, Recreation, Wildlife & Fisheries, and Economic Development. These areas are crucial to the future of the Basin community," said Tweed.

The 2025 award will be presented at the Annual Joint Water Convention Awards Banquet on Thursday, December 11th, at the Bismarck Hotel (formerly the Ramkota) in Bismarck.rck.
